Thank you for your interest in being a Vendor! This show will feature makers who offer a variety of high-quality, handmade goods. This show is all about celebrating the art and soul of craft within our community; our goal is to promote local artisans, foster an appreciation for handmade culture and provide a delightful shopping experience for all.

Vendor Eligibility:

- Show type: Semi-juried handmade craft show. With so many great vendors applying, jurying is a difficult job, but it is done to ensure a healthy mix of products
- Focus: High-quality, handmade goods created by you (or by a friend/family member whose products you're helping sell)
- Accepted products: Handmade crafts such as sewing, woodworking, knitting/crochet jewellery, soap, original artwork, craft supplies, and books
- Not accepted: Resale or direct-sale products (e.g. Scentsy, Jamberry, and similar brands)

Booth information:

- Cost: \$35
- Space: One 10-foot table and seating provided per vendor
- Vendors must bring their own display equipment
- Maximum of one booth per vendor
- Booth sharing is permitted if both vendors' information is included in the application

Selection Process:

- Applications are generally accepted on a first-come, first-served basis
- Organizers reserve the right to:
 - o Decline applications that don't meet the handmade criteria
 - o Limit the number of vendors in the same product category
- Once spaces are full, additional applicants are placed on a waitlist

Setup & Event Hours:

- Setup: 8:30am-9:50am (not before 8:30am)
- Show opens: 10am
- Teardown: Begins at 3pm and must be completed by 4pm
- Indoor event
- Nothing may be taped or hung on the walls

Amenities:

- Canteen available - cash only
- Electricity may be available upon request
- Vendors are responsible for their own displays and décor

Payment:

- Do not send payment with your application
- After approval, you'll receive an invoice
- Payment methods:
 - o E-transfer
 - o Cash
 - o Cheque (must clear before event)
- Payment is due within two weeks of receiving the invoice

Cancellation Policy:

- Cancel no later than 12pm, October 1st for a full refund
- No refunds for cancellations after 12pm, October 1st
